Our company has established our client vaulting solution in affiliation with the vaulting agents Malca-Amit, the globally recognised logistics, security & vaulting company. Our premise was to design a vaulting solution that is not only unique in the market but more importantly guarantees the clients total ownership rights and complete segregation, our company has no title rights or access to the metals held on behalf of our clients, vaults which are entirely operated by Malca-Amit within the world 'A' class bonded vaulting facility of Le Freeport in Singapore.

A unique, highly secure cost-effective solution for our clients vaulting needs.



❖ ULTIMATE SECURITY

You cannot store your metals within a safer and more secure vaulting environment.

Indigo has its own designated vault, which is solely operated and controlled by the team at Malca-Amit. Our company staff are not allowed within the vault without Malca-Amit staff being present and overseeing at all times.

Our staff are not allowed to open any of the segregated boxes unless the vaulting agents give us access (Indigo's own stock) or viewing access to our client's vaulted boxed holdings only.

We are not allowed access to our client's boxes and segregated holdings without full client permissions and acknowledgment.

The vault designated for IPM Group is covered internally and externally by multiple HD cameras that are watched live by Malca-Amit central control offices.

Indigo Vaulting uses only independent, non-bank, 'A' class vaulting facilities, with armed guards and 24/7 surveillance.



❖ FULLY ALLOCATED & SEGREGATED

The physical precious metals you purchase is shipped or transferred directly into your storage, and held in full in your account's name and title (individually, joint or via company name).

No pool accounts, no shared ownership, and no fractional claims on large bars—just what you have bought, in your ownership title, all the time.



Segregated Boxes - The client's metals are submitted into a sealed tamper-proof bag with their own "serial number" imprinted on the bag, name and various other identification details, these bags are then placed in the client's boxes.

When our clients receive their vaulting documentation, paperwork includes their "seal number" to the bag and full details of the bag contents inclusive of bar numbers or coin descriptions.

All transactions from the client's segregated holdings can only take place once the client has completed a release form and signed. The vaulting agent then enters your vaulted box and removes the contents from the bag and places them in the vaulted holdings of wherever you requested them to be placed.

If coins or bars are removed (sold or transferred) from the bag on the client's request the remainder of the coins have to be submitted into a new tamper-proof bag with new seal number, vaulting documentation is updated and sent on the same day.

Photograph Ownership - Clients can request photographs of their tamper-proof bags with their coins or bars sealed within, evidence of seal numbers and ID, which are undertaken by the vaulting agents themselves.

Client Visits - Our clients are actively encouraged to visit the vaults and view their holdings.



❖ FULL LIABILITY COVERAGE AND INDEPENDENTLY AUDITED

Your precious metal holdings has full liability coverage for full replacement value matching your vaulted holding reports. Vaulted client holdings are audited by a leading independent commodities inspection firm and also verified regularly by our vaulting agents.

You can log on to view your account 24/7 via our bespoke vaulting database system.

❖ ANYTIME DELIVERY

If you would like to transfer some or all of your metals then just contact us direct. Metals can be shipped to your address of record, or you can have them delivered to another address almost anywhere in the world (subject to security verification to protect your assets and a small delivery fee). We can also organise transfers to another vaulting facility domestically or overseas. You can even transfer some or all of your holdings between vaults in the same facility.

❖ OUTSIDE THE BANKING SYSTEM

Your bullion is stored in a professional highly secure private vault, outside of the banking system. Safe deposit boxes can be easily seized, are subject to bank closures, they also come with limited insurance coverage and dubious privacy, and are not designed to hold for bulk investment metal storage.

Remember, one reason we own physical bullion is to protect against the banking system, defaults and bail-ins.

❖ EASY TO OPEN, EASY TO BUY WITH FULL DOCUMENTATION

Just select your products, select you wish to store within the vault and then buy online.

We will contact you to forward the relevant documentation to complete and open your family or corporate titled vault.

Once your payment clears, your metal is shipped or transferred directly into your vault. You will receive full documentation of vault deposits, signed from our vaulting agents, which we will forward onto you. You will be given full access to the vaulting database system to monitor your holdings.

We will also forward you the liability coverage certificate.

❖ **EASY SELLING**

You can sell back your holdings from storage at any time. This makes your exit plan easy, simple, and quick. No requirements and inconvenience with packing up your coins or bars, and traveling to a bullion dealer's shop or financial institution. This advantage makes your metal highly liquid and viable at all times as once submitted and vaulted within a bonded vault it effectively enters the 'chain of integrity' which readily accepted globally.
