



Ensure you submit the necessary identification documentation (copies thereof are accepted via email) as listed on the Account Opening form

Once we've received all of your documents, our team will proceed to process them and carry out the required due diligence. Our vaulting agents will then send out your vaulting contracts which should be checked and signed. In some cases we are able to expedite vault openings on behalf of clients (the process can take as little as 24 hours so please advise us of your particular requirements). IPM Group is available throughout the process to advise you, so please reach out to any member of our team with queries.

#### Opening a Joint Account

We always recommend opening your vaulted account jointly with your legal spouse (if any). This circumvents any death probate issues. In the event of decease, your vault will instantly fall into the ownership of the person(s) stated. You may request to appoint 'Authorised Person(s)' to your vaulted account to sign off any documents upon selling of your holdings, in the event of your absence. Authorised person(s), however, do not have any rights over your holdings or will not be able to terminate the account.






#### Prefer Not to Pre-Credit? No Problem.

Once your purchase is complete and funds have cleared, your physical precious metals are seamlessly transferred into your personal vault at Le Freeport Singapore, under the care of our esteemed vaulting partner, Malca-Amit.

For your peace of mind and full transparency, the following documentation is available upon request:

#### Vaulted Report

A comprehensive inventory detailing the exact contents of your vault, including full specifications, vaulting dates, and the duration of storage. Reports are issued quarterly, and can also be downloaded anytime via your secure online portal.

#### Inventory Manifest Photo Report

For clients unable to make an in-person vault visit, we offer a photographic record of your holdings—your proof, in pixels. This service is available for a nominal fee of USD \$15 (or equivalent) per product or package page.

#### Insurance Certificate

Once all original signed documentation has been received, you will be issued a personalized insurance certificate confirming full coverage of your vaulted assets.

With us, your metals aren't just stored—they're safeguarded, insured, and accounted for, down to the gram.



#### Secure, Verified, and Fully Insured Transit

Your investment bars are air-freighted directly from the mint (e.g. London) to Le Freeport, Singapore, where they are weighed, X-rayed, and re-verified by our vaulting partner, Malca-Amit, before being placed into segregated storage.

For added peace of mind, you may request an insurance certificate issued by Lloyd's of London, covering your full vaulted inventory under your family name. This service is available for a small administrative fee.


